All building owners, landlords and employers have a legal responsibility to protect those using their premises from harm or health hazards. This includes the water supply, and is covered by guidelines known as ACOP L8, for the prevention and control of Legionella. These obligations do not have to be complex or difficult—most (if not all) of the routine monitoring requirements can be done in house by your own staff., with minimum instruction or disruption.

Typical services include:

Typical remedial works include:

Water Tank insulation, Lid replacement,
screened vents and insect/rodent screens.
Pipework insulation, hot water cylinder jackets.
Hot water temperature adjustment to compliant level
Outlet de-scaling or replacement (anti-scale) nozzles
Automatic flushing units for little used outlet points.
Removal of old pipework dead legs.

Legionella Risk Assessments and Approved Code of Practice (ACoP) L8 Site Water Log Books

To meet current legislation on controlling the risk of Legionella and monitoring Legionella under the ACoP's L8.

System Diagnostics

The analysis of water systems and the critical flow path formulating a programme to manage your water system.

Remote Monthly Temperatures

An automatic way of taking monthly water temperatures, assisting you in meeting the HSE ACoP's L8 guidelines.

The remotely accessed web-based system removes the need for manual monthly temperature checking.

Automatic flushing of little used outlets

Remove the need to go around your system on a weekly basis manually flushing all little used outlets.

Remove the potential for human error - missing certain outlets, forgetting/or simply too busy to do the weekly flushing, and thereby failing to comply with the HSE ACoP's L8 requirements for the control of Legionella.

Tank & Calorifier Inspection

A thorough inspection of the cold water storage tanks to check whether they meet with current compliance. Including physical condition and acceptability of tank and lid, protective thermal insulation, screened vents to breather and overflow, expansion vent pipes, as well as assessment of the visual water quality of the water contained within.

Similarly, with hot water calorifiers, a general inspection and report on condition and quality of cylinder, thermal lagging, operation of thermometers, facilities for routine draindown and accessibility for cleaning/de-scaling.

Water Quality Sampling & Advice - UKAS approved analysis.

There is potential for micro-organisms to proliferate in various parts of the hot and cold water systems at different times of the year. This could manifest itself into taste, odour or health problems; - poor conditions also support microbiological growth of Legionella. Microbiological testing of hot and cold water systems, for both potability and Legionella, will determine the physical quality of the water, its wholesomeness and suitability for purpose (drinking, irrigation, etc.).

Disinfections

In accordance with ACoP L8 and BS 6700 - the cleaning and disinfection of water tanks and pipework systems to address bacterial contamination and growth, including the prevention of legionella.

Shower Head and Hose replacement or exchange scheme.

A recycling scheme to replace shower heads and hoses on a regular periodic basis (monthly/quarterly) with a cleaned, de-scaled and disinfected replacement handset. Ideal for hospitals, healthcare facilities, care homes, etc.

Alternatively, provision of an efficient and economic disposable shower hose and handset, with smooth surface hose and minimal handset components to minimise opportunistic bacterial colonisation. Hygienic & ideal for medical applications.

Spray-less, Scale resistant tap nozzles

Replacement tap head nozzles made from a special material (5 times more resistant to scale build up than conventional materials), with flow straighteners to prevent aerosol formation. Also available with water saving adjustable flow restriction device.

Quarterly de-scale of taps & showers, Shower head & hose inspections, Tap inspections for scale and aerosol formation.
